**Message from Minoru Horiuchi
President**

“One of the top projects of the U.S.A. Section is the Continuing Education Conference supported by the U.S.A. Foundation. We celebrated the 15th Anniversary of the CEC at Grand Traverse Resort on the northern shores of Lake Michigan on July 9-13, 1997. It was sold out! We hope to see you July 23-25, 1998 in Toronto, Canada.

“In a few weeks, I will represent the U.S.A. Section at the Annual Meeting of the Japan Section at Hakone, Japan. They are celebrating the 40th Anniversary of the establishment of the Japan Section.

“September 2-4, 1997, the International College of Dentists will be holding the third International Induction in Kyongju, Korea (200 miles south from Seoul). All U.S.A. Section candidates for induction in Washington, D.C. and candidates from other countries will be offered the opportunity to be inducted at this worldwide event, prior to the FDI Meeting in Seoul, Korea.

“The 1997 Convocation and Banquet of the U.S.A. Section of the International College of Dentists will be held in Washington, D.C. on October 17, 1997. Our Induction Speaker will be Dr. James E. Mulvihill, President and Chief Executive Officer of the Juvenile Diabetes Foundation International of New York. Please come and join us.

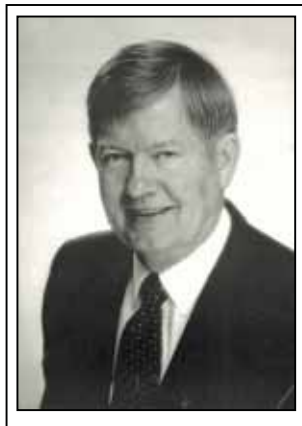

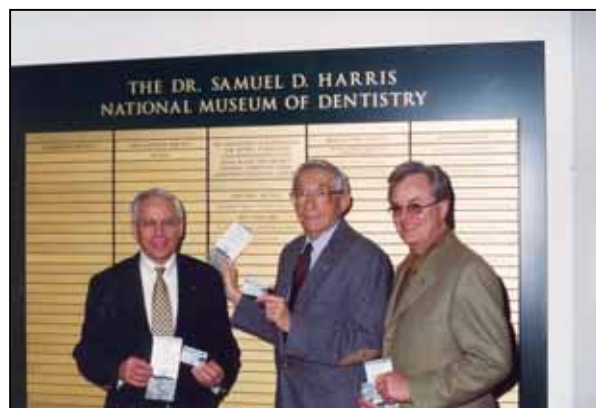

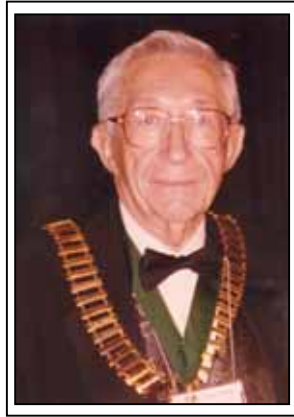

**Message from Emanuel W. Michaels
President**

**Message from Richard A. Shick
President**

“Leadership, communication and achievement are primary goals of the USA Section of the International College of Dentists. Therefore the

very productive “informal planning sessions” started by Drs. Emmering and Compaan immediately following the Annual Meeting was continued. The informal sessions included only the officers, no staff present. The new President laid out his agenda, brainstorming reigned supreme and it was an orientation session for the newly-elected Vice President. This approach to governing provided the Executive Committee an opportunity to achieve an enthusiastic jump-start with no initial down time between October and January. Lastly, it was an opportunity for the outgoing President to give advice, thoughts of wisdom or suggest goals that should be pursued. It was a tremendously productive two hours spent preparing for the coming year.

“Immediately after being installed as President, Drs. Felix and Sampe were appointed to Chair a committee that ultimately identified a Humanitarian Outreach Project for establishing a Dental Public Health Specialty Training Program at the School of Dentistry in Ho Chi Min City, Vietnam. Health Volunteers Overseas conceived this program in cooperation with the ADA. The Curriculum was developed and voluntary staff acquired by Dr. Martin Hobdell of the University of Texas. The project was supported through voluntary contributions and funded for two years at a cost of \$25,000. After two years, 17 Dentists received certificates as Specialists in Public Health Dentistry. Subsequently, two of those dentists received a Masters degree in Public Health Dentistry. The Specialty program has now been assumed by the School of Dentistry and will continue indefinitely. This Humanitarian Outreach program moved into Cambodia with the same success, training 23 Specialists in Public Health Dentistry. Now the USA Section is financing this program in Laos and plans to carry it next to Africa.

“The Triennial Leadership Conference which occurred during the 2001 year provided two years to consider what to accomplish. After finalizing those thoughts and plans, a meeting was scheduled in the Central Office with Registrar Brady. The entire day was utilized to fine-tune and flesh-out all the details of topics, assignments and items to consider.

“For the edification of the attendees (particularly the Deputy Regents), 18 persons were selected to give presentations on ten major leadership positions within the College and Section. Three of those 18 persons were selected to give presentations on two important committees and the Candidate Information Form (CIF). The attendees were assigned to five different Working Groups. They were given extensive questions to consider and asked to provide suggestions and recommendations for the improvement of the operation of the ICD and specifically the USA Section. Recorders provided information on recommendations and conclusions. Two Regents were appointed to review, collate and consolidate the recommendations so the BOR could take action.

“There were ten visitations to Constituents during the year. The highlight of those visitations was the 20-minute keynote address given to ICD, ACD and PFA members during the Hinman meeting, titled, ‘Personal rewards for voluntary service.’

“An orientation program for Regents was a goal I had been unsuccessful in getting implemented for several years. As President, I simply used the document that I had developed, scheduled the sessions and conducted the orientations myself. Because of the favorable response, the next year President Charles Simons requested the continuation of the same Orientation Program for new Regents.

“Six years prior to assuming the Presidency, I had the privilege of Chairing a Committee that proposed collecting State dues at the National level. There was great opposition but with time and persistence, it was agreed to have a trial national collection with four states. The experience was so favorable that eventually all states except two implemented collection of dues at the National level. Today, the states have such excellent financial status that they can function in multiple activities including humanitarian programs.

“The innovative three-year rolling contract for the Registrar was proposed and adopted by the BOR. Such a contract permits for more effective

future planning for both the BOR and the Registrar.

“In cooperation with the College, an Information Technology Committee was appointed and adequately funded to bring the Central Office and the ICD into the 21st Century's world of electronic communications.

“There was a significant disappointment during my administration. I believed there was a definite need to alter our selection process for those we record as Leaders in Dentistry. It was suggested that we appoint an outside blue ribbon ADVISORY COMMITTEE. This Advisory committee would annually be given the names of the dentists we have recorded and the names on the list for potential recording. The committee would be asked whom they would recommend we select to record from our list. In addition the Committee would be asked to provide names of other deserving individuals the ICD should consider recording. Such action would greatly improve our selection process and credibility with the profession at large. Thereby making our recordings of The Leaders in Dentistry outstanding and more valuable as time goes on. The BOR rejected this recommendation.”

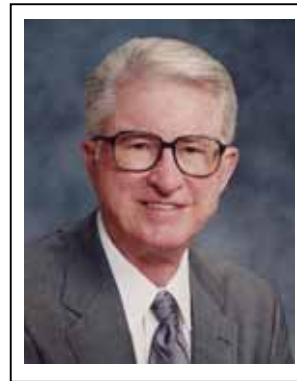

Message from Carl G. Lundgren President

"A family is what we are. There are 5,715 of us in the United States. We are all leaders and it seems as though the leaders regularly do things together and become good friends. And our spouses and associates are all part of the family. This is the fun of it. At the same time, we all get enormous satisfaction out of the good that we can do for others.

"To continue to build on an already superb organization is a worthy goal. Exciting projects to propel the USA-ICD are going steadily forward. There are about two score proven leaders among the Board of Regents and the Past Presidents who are igniting a broad spectrum of meritorious projects. Its Foundation has a variety of projects that it supports. Many of the state ICD groups have their own philanthropic projects as well.

“This year, we have been vastly expanding our web page. Log onto USA-ICD.org and you will be able to watch it unfold. Already, its “Careers in Dentistry” page gets an enormous number of visits. See what the various Outreach/Action Committees are now doing on the new page called “ICDoings”. There are about a dozen different projects that are planned for being featured, a month or so at a time. They include:

- The Audio-Visual Series – taped interviews of the World’s Leaders in Dentistry. Who are they? What did they do? Who are the new ones this year?
- Exchange Student programs involving dental students from the United States, learning in other countries and vice versa.
- The Humanitarian Dental Outreach Program to train seventeen (17) dentists to develop a public dental health structure in Vietnam where there are only 1,600 dentists to treat 78 million people. We raised about \$30,000 of non-dues money to fully fund this. Cambodia is next, and the planning is underway, with more funding coming in well.
- Upcoming summer CEC programs in: Minneapolis, MN in 2005; Halifax, Nova Scotia in 2006 and Atlanta, GA in 2007. These will occur in the second week of July. What are the social events? How can you arrange to attend?
- New projects such as the White Coat Ceremony involvement.
- Journalism Awards – We are famous for this one.
- History of ICD and its achievements – A prologue of the future.
- Fellowship Orientation Program.
- The Convocation – behind the scenes.
- Many states have their own programs. What are they?

“Our website, see the new ICD roster with your name in it. We will no longer be publishing a

hard copy. This will save us about \$25,000 per issue.

“Also, on our website, see how you can easily obtain an ICD Visa credit card that is good for air mileage credits. We get a cut on the income from each new card issued.

“I would like to see an expansion of the local states’ ICD projects. This not only supports worthwhile projects but it brings Fellows together. One such idea is to be involved with charitable efforts in clinics for the underserved. There are many. Use your imagination. There is plenty of need out there.

“Yes, the USA-ICD is one big family. One that deserves participation by all of us.”

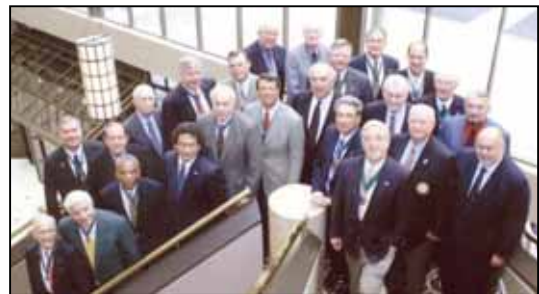

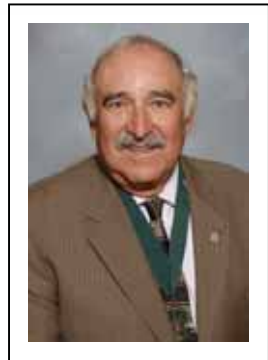

“As the credentials for the induction class of 2007 were reviewed, it was immediately apparent that leadership in Dentistry was alive and well. The Fellows of the Class of 2007 were an absolutely outstanding group of individuals. They were prominent in their communities, in their profession and, in the spirit of sharing the talents that were given to them by good fortune. It was an impressive and proud group. May we always be so fortunate.

“The results of the Committee work in 2007 were an affirmation of the missions of the ICD. We were effective with new member recruiting, the missions in Tanzania, Kikuyu and Southeast Asia, the Student Exchange Program, the Leadership Initiative Program, our organizational communications, and in policy discussions regarding the business relations with the College and with the Foundation.

“The issue of recruitment is always a measure of the visibility of an organization with the membership. This year we finalized the new member class in May which was the earliest closing date in the history of the new member class for the USA Section of the ICD. This was due to the outstanding efforts of the Deputy Regents for their efforts in representing the value system of the ICD. New members do not happen by accident but only happen with hard work and a viable value system.

“A primary goal for 2007 was to begin a process of including the Board of Regents in policy decisions and discussions. We deliberately foreshortened the business agendas and allowed open discussion on policy throughout most of the day at the meetings in Atlanta and San Francisco. I thoroughly enjoyed the participation of the Board in policy decisions and look forward to that strategy into the future.

“Tanzania was truly a project in which the ICD made a difference. The impact was huge. For \$15,000 of support, we got discounted prices on two operatories full of equipment, the transfer of two old operatories of equipment to a field unit and, volunteer dentists to begin operating the

program. We are grateful to the American Dental Association, Health Volunteers Overseas and the Colgate Palmolive Company for the joint support. We will affect the lives of those 150,000 refugees with this program.

“The Southeast Asia program is in the eighth year of education of the dentists of that area: Vietnam, Cambodia, and Laos. We have now trained over seventy dentists in concepts of Public Healthy Dentistry. Recent graduates have been instrumental in leading the government in fluoridating the water at Ho Chi Minh City. There is a continuing impetus for the fluoridation program to continue into other areas. This has had a major impact on the people of Southeast Asia. Dr. Martin Hobdell received the ICD Distinguished Leadership Award for his efforts with that program. He has been a truly dedicated person and we are very grateful.

“Communications accounted for a considerable part of our activities in 2007. This was the second year of the *KEY-mail* program. It has been extremely successful in transmitting information on topics of current interest and it will be continued.

“The USA Section continues to promote dental journalism. Each year editors of English language dental journals are recognized for their special talents. This year, the ICD recognized sixteen (16) American and Canadian editors and authors for outstanding contributions.

“The Leadership Initiative program continues to make significant progress. White Coat Ceremonies were expanded, sponsorship opportunities were launched for a Leadership Institute and the Leadership Coordinator Manual was completed.

“The USA Section Student Exchange Program continues with remarkable success. This year we will fund fifteen (15) at ten (10) dental schools.”

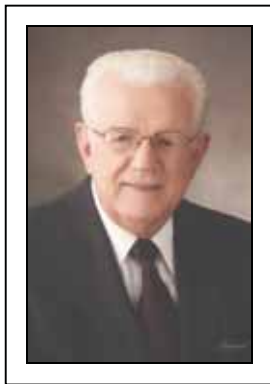

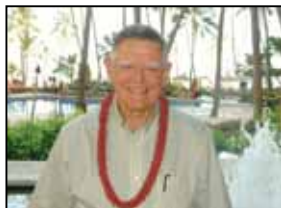
