Year Four in Houston

At UTDB Houston, the Great Expectations (GE) is based on mutual respect between all parties involved in the program. The underlying idea is the second year dental students are students for a short time but colleagues for life. With these principles as our foundation, we work together to mentor the sophomore class at UTDB Houston as they prepare to enter the clinics to see their first patients.

Perhaps the biggest compliment of GE in Houston is that the program has been incorporated as an adjunct to the curriculum. The second year students are already organized into color groups of about seventeen students. There is a Primary Bay Instructor (PBI) assigned to each color group and the color groups begin to meet during the fall semester to prepare the students for their first patient encounters in the spring semester. Great Expectations utilizes the same color groups with their

PBIs and adds two Texas Section ICD Mentors (per color group) along with a third and fourth year dental student to serve as student mentors.

The Kick-Off Event took place at UTDB Houston on Wednesday, October 20. Italian food was served and the program was a big success. Follow up meetings at the individual ICD Mentor's dental offices will take place in November with a Year End Wrap Up Event in April, 2011.

Texas Section ICD Mentor Dentists include, Doug Bogan, Bill Birdwell, Rita Cammarata, Shelley Canada, Lee Clitheroe, Ron Collins, Jim Condrey, Kathy Gibson, Tommy Harrison, Greg Oelfke, Boyd Shepherd and John Valenza. The heart and the sole of the Houston GE Program is Phil Pierpont, Assistant Dean for Student and Alumni Affairs, University of Texas Dental Branch, Houston. The program provides an excellent opportunity for dental students to speak on a more equal footing with practicing dentists about issues with an emphasis on ethics and professionalism.

Mentoring in Romania

For the past four years, Baylor College of Dentistry has matched up first year students with dentists from the Dallas area as part of the Great Expectations Mentoring Program. Students get the opportunity to build a relationship with an established dentist who can share their experiences, both good and bad. The practicing dentist in my mentoring group, Dr. Kevin Seidler, established an international medical and dental mission organization, ServingHIM, in the late 1990's. Dr. Seidler leads a team from Dallas every year to Braila, a small town in southeastern Romania, where ServingHIM recently built a four-story clinic. The first time my mentoring group met with Dr. Seidler, he told us about his passion for international missions and invited us on his next trip. This simple invitation eventually changed the lives of five Baylor dental students.

In the summer of 2009, after completing our first year in dental school, we traveled to the other side of the world with Dr. Seidler. Other dentists not affiliated with Baylor College of Dentistry were also members of the team. In Romania, he mentored
