This is a summary of the new Fellowship Brochure for your use, it is not a complete presentation.

HONOR

The *International College of Dentists* is the preeminent honorary organization of the world's outstanding dentists who have, by their actions, demonstrated an abiding interest and concern for their profession.

One of the most significant events in a person's career is that of being recognized as a Fellow of an organization of professional distinction.

In the dental profession, such acceptance signifies that one has brought honor to the profession through devoted service and high ethical behavior, and that in return, one is bestowed the highest honor of that profession through acceptance as a Fellow in the *International College of Dentists*.

ORGANIZATION

The *International College of Dentists* was created in 1928 by *Dr. Louis Ottofy* with the help of *Dr. Tsurukich Okumura* of Japan. Its purpose was to promote cordial relations within the profession and help disseminate scientific information.

The College was formed to advance the science and art of dentistry for the health and welfare of the public, to bring together the world's outstanding members of the dental profession for the exchange of dental knowledge, and to encourage the growth of the profession worldwide.

OBJECTIVES

The objectives of the International College of Dentists are:

- To bring together outstanding members of the profession throughout the world to foster growth and dissemination of knowledge and promote goodwill among members of the profession.
- To cultivate cordial relations among people in dentistry and those in other health professions.
- To elevate the stature of the profession requiring the highest standards of ethical and professional conduct of its members, who must recognize their civic and social obligations as good citizens of their community and who must accept their extraordinary responsibilities as members of their profession.
- To work with other organizations for the prevention of oral disorders.
- To encourage postgraduate study and research.
- To preserve the history of dentistry.
- To advance the science and art of dentistry for the health and welfare of the public.

SELECTION

The *International College of Dentists* has an extensive process of screening candidates for acceptance to Fellowship. Candidate qualifications are evaluated by as many as 25 Fellows during the screening process, which ensures the highest quality of membership in the *International College of Dentists*.

The limited membership in the College is by design, paradoxically contrasting its worldwide involvement.

The College membership totals over 7,600 — with 4,600 members in the USA Section and about 3,000 members in sections around the world.

PROJECTS

The USA Section of the *International College of Dentists* has many projects, among which are the following: Annual Continuing Education Conference; Annual Dental Journalism Awards and Seminar; Outstanding Senior Student Award for professional growth and development; International Dental Student Exchange Program; International Clinicians Program; Audiovisual History Program; and International College of Dentists USA Section Foundation.

s I have made my presidential visitations to the various states this year, I have chosen to deviate from the standard format of "Greetings From the Board of Regents" and Project descriptions in favor of the opportunity to promote the "Objectives of the College" and stimulate Fellow awareness of some of the current issues affecting our profession. For the record though, let me capitalize upon this opportunity, in print, to comment on the status of the USA Section which is sound, both financially and functionally.

I have worked with many organizations over the years, some good and some bad; but never have I had the opportunity to work with a group more talented and fine tuned than this Section of the College. We owe a great deal of thanks to Frank Kenward for the groundwork he laid and now to Dick Shaffer, for his expert leadership; Florence Fallavollita, for perfection in office administration; "Satch" Selfridge, for unequaled continuing education programs; and to the Committees of the Section for fiscal responsibility and flawless performances. It doesn't



get any better than this.

One of the most pressing issues affecting our profession is the growing feeling that dentistry must follow in the footsteps of medicine and accept "Managed Care" as a replacement for the traditional "fee for service, private practice of dentistry". This is nonsense! Dentistry did not bring on nor participate in the cost escalation we are seeing in health care. Dental care accounts for only 4% of the health care dollar

and a review of fees over the past 20 years shows dentistry to be in line with cost of living increases and only out of line due to overhead expense brought on by CDC and OSHA regulations.

If we follow the "Objectives of the College" we must continue to move forward; if we allow third parties to dictate the quality and frequency of care, the welfare and health of the public will ultimately suffer. We need the best minds in dentistry to guide our profession through this crisis and to inform the leaders of America's corporations as to which programs are sound programs for their employees. Those best minds are Fellows of this College; and I call upon YOU to get involved, stay involved, and continue to make dentistry a leader, not a follower.

I also invite each of you to join us in Las Vegas on October 6th at the Riviera Hotel for the Annual Convocation where we will be addressed by Fellow Charlie Norwood, a member of Congress, and one of the "good guys".



The College's Deputy Regents fill an awesome role

Their functioning determines success

Il organizations have offices of responsibility. The International College USA Section is no exception. These range from the Registrar to the Editors of the Section or Component. There is, however, a major responsibility placed on the Deputy Regent.

Chosen for qualities of leadership, stature in the state and his/ her community, his/her willingness to work closely with his/her colleagues, state officers and Regent, the Deputy Regent bears an awesome grass roots responsibility in seeing that our process works and is successful. The enthusiasm of the state and the success of meeting the objectives of the USA Section is dependent on the responsible functioning of the Deputy Regent. This cannot be accomplished without a thorough knowledge of the Constitution and Bylaws of our Section.

The Deputy Regent's first task is to nominate the members of the Screening Committee and appoint Counselors and the Editor. Beyond this is the need to encourage and support these persons and see that they function responsibly.

Names of suggested candidates are received and referred to the Screening Committee. The committee is given support and is responsible for the timely response in writing.

Following the committee's approval, the necessary Candidate

Information Form is provided to the sponsor of the candidate. A very major responsibility of the Deputy Regent is to determine that the CIF is totally completed, especially Section 14 and 15 on non-dental organizations, philanthropic and community activities, and all signatures are present before forwarding the form to the Regent for action.

It is necessary to keep a record of the procedure and ensure that all activity and information is kept confidential.

There are other areas that need attention, too. Resting with the Deputy Regent are the details of seeing that arrangements are made for meetings, that deaths, resignations, retirements, payment delinquency and other record keeping matters are reported to the Regent and the Central Office. Encouragement must be given to members attendance at meetings, and attendance at our annual induction and dinner dance, especially the sponsors inductees.

Through all this work, frequent contact with the Regent must be maintained giving a report on meetings, making recommendations on the process of induction, and filing an annual report.

You can now understand the responsibility placed on the Deputy Regent. They must be truly dedicated to our College to accept this role. These devoted servants deserve sincere thanks from all the members of our ICD USA Section for their efforts in making our procedure successful and for the success of our College.

Patrick Metro chosen General Chairman of 1996 ADA-FDI World Congress

atrick Metro, 1996 Chairman of the American Dental Association Council on Annual Session and International Programs has been chosen General Chairman for the 1996 ADA-FDI World Congress in Orlando, Florida. This meeting is expected to break all attendance records. A dazzling selection of domestic and international clinicians with simultaneous translation into four foreign languages is expected to draw in excess of over 60,000 attendees from all corners of the globe. In addition, special social events and programs designed to please both the domestic and international taste are being prepared. In planning the enormous logistics for such a meeting, Dr. Metro met with international representatives for preliminary planning in Vancouver last fall and will travel to Hong Kong following the October Las Vegas meeting to work out the final details.

Pat is also serving a three year term on the Board of Governors of the National Council for International Health (NCIH) as the sole representative of the ADA. This is the first time the ADA has had a representative on the Board of Governors. In addition, Dr. Metro was elected by the Board of Governors to a one year term (1995) on the seven member executive committee, a singular honor and first ever for dentistry.

Charlie Norwood — ends up in the most amazing places

Sets his goal for the sun — aims for the moon

ormer Georgia Dental **Association President** and now president of the USA Section of the International College of Dentists, Dr. Donald E. Johnson, has been doing some barnstorming of late. President Johnson has been touring the country representing ICD and speaking to his now familiar theme of responsibility and accountability. Dr. Johnson believes dentistry has never been more in need of senior, experienced, leadership than it is today. He says, "the ICD has as its members, the brightest, the most talented, and the most experienced dentists in our country. We must stand up for dentistry and not sit back and watch changes take place simply because we don't think they will affect us before we retire."

One member of the International College of Dentists who has stepped forward to display his commitment and to fulfill the challenges issued by Dr. Johnson is Dr. Charles W. Norwood, Jr. from Augusta, Georgia.

As early as 1993, Charlie began a new era in his career by showing his responsibility and his willingness to be a leader in manifesting his beliefs. He believed so strongly that government had to be reformed if his grandchildren were to grow up and enjoy a comfortable quality of life, he sold his thriving dental practice and announced he was a candidate for the U.S. Congress. With a potent vision for governmental reform, the Georgia Dental Association's former leader and 116th President, turned politician. He tried out his new political wings by asserting to fellow dentists, "maybe you can't vote for me [10th District Georgia], but I can vote for you."

For the next 13 months, Charlie, as he is known around Georgia, stormed the tenth district attempting to meet every possible voter and canvassed the state to raise every possible campaign contribution in his run to be a U.S. Representative. During his successful campaign for Republican Congressman from Georgia, Charlie promised tax payers he would fight for reforms leading toward a balanced budget and tax relief. He promised mothers he would fight for legislation to help stop crime and improve the failing judicial system. And he promised dentists he would not rest until Joseph Dear (head of OSHA)

heard and responded to dentistry's need for regulatory reform.

Until their debates in late October became the most televised in Georgia history, Charlie and the Democratic incumbent were locked in a nail-biting battle. But Charlie's straight-talk politics won 67% of the vote in November and Charlie and his much admired wife, Gloria, took up residence in the nation's capitol.

Before his political ambitions ever materialized, Gloria said about him, "Charlie is great fun to watch, he always sets his goals for the sun while aiming for the moon — and ends up in the most amazing

The prominent project of the ICD USA Section is our Audiovisual History Series

Significant contributions of dental leaders recognized

here are many names in dentistry, past and present, that you may know as you read dental literature as having made significant contributions to our profession. The USA Section of the ICD perceived that many of these leaders needed to be recognized and that their contribution be perpetuated. Thus was borne the project "Outstanding Leaders in Dentistry/An Audiovisual History Series."

The College presents a VHS video taped series by outstanding leaders reviewing their accomplishments and presenting their views on the dental profession. Clinicians, practitioners, researchers and educators who have made significant contributions to our profession are recognized in these tapes. Important events in their lives provide human interest aspects with historic value. The interviewees included why they chose dentistry as a career, the factor that influenced the character and timing of their contributions, and their views of dentistry's past. and future from their own historical perspective. During the annual meeting in Atlanta in 1984 the USA Section of the ICD recognized its roll in fostering projects in dentistry by approving a project to record outstanding and famous leaders in dentistry on videotape. The idea of these tapes was based upon the recognition that there are individuals who, because of their clinical or administrative

responsibilities, that might not have kept accurate records of their lives through journals or diaries. The intimacy of television interviews allows the thoughts and views of distinguished leaders in dentistry to be preserved for future generations.

The idea for these tapes came from fellow **Richard Adelson**. He did an interview with Dr. David Grainger, who at the time, was at the School of Dentistry, University of Florida. The impact of this tape came, when at the end of the interview, Dr. Adelson said, in effect, "We'll meet in ten years and see how many of your predictions come true." The following year Dr. Grainger died.

Fellows Adelson and Earl Collard had attempted to get three major dental organizations to fund the project to interview other outstanding dentists, realizing from this one tape how quickly life can end and all of the personality of the individual can be lost forever. These attempts did not succeed.

Earl Collard played the Grainger tape to **William C. Hopkins**. He was so impressed he immediately set out to put together a program for a presentation to the USA Section of the ICD, to create a project for TV interviews and to adequately fund the project.

Earl and Bill studied and worked many hours to put together a proposal, outlining the purpose of the project, objectives, and an agenda was proposed for a meeting with College Registrar Frank Kenward, Richard Adelson, and film editor George Karakus from the TV media at the University of Oklahoma in Oklahoma City, November 18, 1983.

The group developed a most important aspect of this proposal, that being our purpose. The purpose of this project is to:

- (1) Plan and implement a series of videotaped interviews with elder statesmen who have made significant contributions to the art, science and profession of dentistry.
- (2) To develop a plan for publicity, storage and distribution of these videotapes.
- (3) To make recommendations about potential uses of these tapes and to target audiences.

"The presentation required time and research."

The Ad Hoc group developed a presentation to give at the next meeting of the Board of Regents. A great deal of time and research went into the development of this project. Richard Adelson and Dr. Fran Watkins, Chairman of the Department of Continuing Education at the University of Oklahoma, gave very generously of their time as consultants to develop this project. With their (continued on page 12)

expertise a pilot program was developed which was funded by the USA Section of the College. H.O. "Westy" Westerdahl, our Secretary-General Emeritus, was chosen to be the candidate interviewed. Frank Kenward, who at the time was our Registrar and Secretary-General was chosen to do the interview. The interview was taped at the University of Oklahoma TV studios on the Health Sciences Center campus, Friday, March 16, 1984, in Oklahoma City. William Hopkins suggested a tape be made with Frank Kenward being the candidate. This interview was taped with Bill Hopkins acting as the interviewer. Frank provided the Audio-Visual library with a great deal of history of the International College of Dentists.

The program being put together, the pilot films completed, Bill Hopkins requested the Board of Regents accept the project and fund it properly so it could be an ongoing project. At its Atlanta meeting in 1984, the Board accepted the entire proposal. The first committee members of The Audio-Visual History Committee were appointed by President Richard Rice. The members were: Frank Herbert, Earl Collard, and William Hopkins, Chairman.

The committee began to plan immediately for our first taping in 1985. It selected Dr. **Harold Hillenbrand** as our first candidate to interview. This

interview was filmed in April, 1985. Richard Adelson was the interviewer. The ICD is the only group that has ANY video tape of Dr. Hillenbrand. Dr. **Maynard K. Hine** was interviewed the same day. These were two giants which we, the committee, captured on videotape for the AV History library.

Thirty-six videotapes have been produced during the past nine years. We have filmed in Washington, DC on several occasions in order to videotape a dignitary from another country while he or she was in Washington. It would have been impossible to bring these people to Oklahoma for a taping session. The video committee has sent our producer-director to Washington in order to maintain the continuity and high quality of productions. Penn Cline, from the TV Media Production at the University of Oklahoma, was a camera man at our first taping and has been involved in all of our tapings. Mr. Cline is now in charge of the TV Media Department and still maintains a vital and enthusiastic attitude toward the ICD project.

Earl Collard, Bill Hopkins, and Chairman Richard Adelson are continuing to produce professional quality tapes, at a very reasonable cost, to insure the ongoing development of our audiovisual library.

These video tapes of outstanding leaders in our profession are intended for use in presentation to professional associations, societies, dental schools, for libraries and for those who have a personal interest in the profession of dentistry. Exceptional dental leaders in the series:

1. Harold Hillenbrand

Dr. Hillenbrand is probably the best known of all dentistry's leaders because of his long tenure (23 years) and accomplishments as dentistry's foremost leader. Harold was recognized world-wide for his leadership and his being the architect of many enduring

programs. Above all, he had a clear vision of what the American profession, and even the world destiny should be and brought it to fruition. The ADA can be considered a monument to his financial acumen, his belief in making no little plans and for his abiding faith in the ongoing future of dentistry. Just to list his honors, degrees from universities everywhere, recognitions from foreign governments and honorary membership in other disciplines would require a voluminous separate publication.

2. Maynard K. Hine

Dr. Hine is considered one of the nation's outstanding dental educators. Upon returning to his dental alma mater, the University of Indiana, he led that school to become one of the outstanding dental schools in the country. He is also active in journalism, the author of many books, articles, and research and has served as the president of the American Dental Association.

3. George W. Ferguson

After twenty-two years on active duty with the U.S. Navy, he served as guest worker at the National Bureau of Standards and was also a brilliant and exceptionally skilled operator. He later joined the faculty of the State University of New York at Buffalo School of Dentistry. He is best known for his leadership in operative dentistry and was featured on 29 scientific programs and 51 others throughout the country and ten programs in foreign countries.

4. Miles R. Markley

An exponent of conservative cavity preparation, he has been credited with combining pins with amalgam for restorations and foundations. A noted lecturer, he is a documented "half million miler" in commercial air travel. He was presenter in all 48 states, 22 U.S. schools and ten foreign schools. A number of his publications are used as teaching material in many dental schools.

5. Lindsey D. Pankey

After vowing to never remove another tooth, he focused on patient communication and the analysis and study of articulation and occlusion and how to work to the highest standards. These were reflected in the success of his practice and his teaching other dentists. The Pankey Institute, with his techniques, was founded and grew to national recognition with hundreds of dentists learning his technique.

6. Clifton O. Dummett

A specialist in periodontics and oral health, an outstanding

clinician, a superior investigator, a superb teacher and an able administrator, he has made major contributions to the field of dental health problems to the public and by focusing the attitude of the profession on the needs of underserved populations.

7. Ralph W. Phillips

For decades he was one of the foremost authorities in the field of dental materials science and research. Throughout an eminent career that spanned 50 years he was widely recognized as the most dynamic and sought after lecturer. He appeared on more than 1,000 programs in the U.S. and around the world and authored 300 scientific papers and books including the *Science of Dental Materials*, one of the most widely used textbooks in history.

8. Elbert O. Thompson

A general practitioner, he is the pioneer and developer of the "washed field dentistry", the "canister tray" concept and the "Euthenics dentistry" concept. A leader in gold foil technique and practice administrator, he served on faculties of several dental schools. He was a noted lecturer before many local, state and national organizations.

9. Jeanne C. Sinkford

A distinguished dental educator of international reknown, administrator, lecturer and clinician, she became the first female head of a prosthetics department and later became the first and only female dean of a dental school, Howard University School of Dentistry. She has authored over 70 publications, notably a manual on crown and bridge prosthodontics and a curriculum for dental materials and oral physiology.

10. Maury Massler

He stressed that dental caries is a disease of the mouth and should be treated as an oral infection and that restorations or appliances placed in an active carious mouth break down very quickly. A teacher, researcher, lecturer, dean and author, he appeared on over 400 programs, was a consultant to seven foreign dental schools and contributed pages to dental journals and authored or co-authored six textbooks.

11. Wilbur E. Eames

Known best for his research studies in the various factors in proportioning mercury and alloy ratios and condensing amalgam, the influence of clinical variables in marginal adaptation, evaluation of trituration and condensing and other studies. He was a prodigious contributor to major dental journals and was a presenter for over 100 programs, television demonstrations, seminars and panel discussions across the U.S. and abroad.

12. Earl E. Shepherd

A tribute to Dr. Shepherd noted that he was a giant among men, respected by his peers, admired by his contemporaries and loved by those he served as mentor. As an author and teacher of orthodontics, his skill in organizational work marked his prominence as a leader. Through his guidance the *American Board of Orthodontics* emerged as one of the most respected certifying boards in dentistry.

13. Nelson W. Rupp

His experience is divided between general dentistry, dental materials research, and education. His over 35 publications in major dental journals dealt with denture base materials, amalgams, cements, composite resins, acid etch retention, and mercury hygiene in the dental office. He is best known for his study of dental composites and dental bonding. His service as a research associate for the ADA and as associate director of the *National Bureau of Standards* highlighted his career.

14. William E. Brown, Jr.

With a wealth of experience in dental education with the University of Michigan School of Dentistry, he was named associate director of the W.K. Kellogg Foundation Institute for Graduate and Post-graduate Dentistry. Among his activities at the national level was his service as a consultant to the ADA Council on Dental Education and as a member of the ADA Task Force which developed the National Children's Dental Health Program. Later he was named the first dean of the yet to be built University of Oklahoma School of Dentistry.

15. David E. Barmes

Following the discovery of a group of New Guineans who were free of dental disease, he led a special study in the etiology of the disease. He has been active in epidemiological and dental services in many countries of the world. After serving in the Dental Health Standing Community of the National Health and Medical

Research Council of Australia and the WHO Expert Advisory Panel on Dental Health, he was appointed chief, Oral Health of the WHO.

16. A. Gordon Rowell

After a long and distinguished active military career, he was appointed Director of Dental Services Army Headquarters and chairman of Dental Services of the Department of Defense in Australia. He was active in dental journalism and made major contributions to the field of prosthodontics as a teacher, author, and research worker and made many contributions to dentistry, both at home and abroad.

17. Basil G. Bibby

As senior scientist emeritus and former director of the Eastman Dental Center, Dr. Bibby had

a long and distinguished career in dental research and education. He is credited with first proving that fluoride reaction with the enamel surface would prevent caries. He encouraged and trained researchers in dentistry, advanced knowledge about the role of oral bacteria, the effect saliva has on the ecological balance in the mouth, and pioneered research into the cariogenicity of food.

18. Robert B. Shira

A distinguished oral surgeon, former Chief of the U.S. Army Dental Corps (Major General), teacher and dean of Tufts University Dental School, he has been a lecturer and clinician at dental meetings in all 50 states and 24 foreign countries. A prolific writer and editor, he has contributed more than 50 articles to the dental literature, written chapters

in 12 dental textbooks, produced 14 dental teaching films for clinicians, served as an editor, and is a past president of the ADA.

19. Jens Pindborg

As an author of 20 books and 360 papers on oral biology, he has given guest lectures in 34 countries and has served as editor or associate editor of 9 journals. Dr. Pindborg was on the scientific expedition for WHO to New Guinea and consultant on field surveys on oral precancer in five countries. He is a noted researcher and authority on odontogenic tumors and allied lesions and heads the EEC Clearing House for oral problems related to the HIV infection.

20. Alvin L. Morris

Dr. Morris is a noted educator specializing in dental therapeutics and administration. He was named dean of the University of Kentucky School of Dentistry, became special assistant to the president of U.K. and was later elevated to vice-president for administration of the university. In 1976 he was named Executive Director of the Association for Academic Health Center located in Washington D.C. In 1979 he was appointed Director of the University of Pennsylvania School of Dental Medicine's Long Range Planning Committee, and chaired the seven member Search Committee for a new ADA Executive Director.

21. Harold Löe

Leaving his position as Dean and Professor of Periodontology at the University of Connecticut School of Dental Medicine, he became the *Director of the National Institute of Dental Research*. He retired in 1994. During his tenure he fostered the growth of oral

all the oral and craniofacial tissues as well as behaviors associated with the cause and prevention of disease and the maintenance of health. He is internationally known for his contribution to dental disease research, his world-wide lectures, and authorship of over 300 papers.

22. Jacob Freedland

Dr. Jacob B. Freedland, an endodontist, is a past president of the American Association of Endodontist, the American Institute of Oral Sciences and is a former director of the American Board of Endontics. He has served as lecturer consultant for the US Naval Dental School and as consultant/advisor on its Graduate Dental Training Program. Dr. Freedland serves also as a consultant for the US Army Institute of Dental Research. He has been awarded the Pierre Fauchard Academy Award, the Thomas P. Hinman Medallion of Meritorious Service, the Distinguished Service Award from the AGD, and the Distinguished Alumnus Award from the University of North Carolina.

23. Irwin D. Mandel

Although probably best known for his early studies of gingival fluid and dental plaque, he has created a body of literature that has formed a cornerstone of modern-day preventive dentistry.

As an educator, researcher, and author, Dr. Mandel has motivated others to use research as a means to advance the practice of dentistry. He has served as consultant to the ADA's Council on Dental Therapeutics, chaired the Council on Dental Research, and served on the ADA's Special Committee on the Future of Dentistry. In 1985 he was awarded the ADA's Gold Medal for Excellence in Dental Research.

24. Nikolai M. Petrovic

Born in Vienna of Russian partenage and background, Nikolai graduated from Monmouth College with a major in journalism and sociology. Working first with Eastern Airlines, he was hired as Director of Special Projects (annual convention and educational programs) for the American Health Care Association. He then became the chief executive of the Packaged Ice Association. Since 1977 he has been president of the American Dental Trade Association. In 1980 he was elected to a term as chairman of the Greater Washington Society of Association Executives, the youngest chairman in that organization's history.

25. José Medina

Beginning his academic career in operative dentistry, he investigated epoxy resin die materials and elastometric impression materials in improving the quality of cast gold restorations. Another area of study involved instrumentation for both rotary and hand cutting tooth structure with its associated factors. Author and teacher, his most significant contribution made to dentistry has been in the field of dental education. He moved rapidly through stages of professorship to Associate Dean of the University of Maryland Dental School. His

capabilities were soon recognized as he participated in the founding of the new University of Florida School of Dentistry. He later became dean of that school and then was named associate vice president for Facilities, Planning and Operation at the J. Hillis Miller Health Center of the University of Florida.

26. Sigurd P. Ramfjord

An internationally renowned lecturer, Dr. Ramfjord has won numerous awards for his research efforts in periodontics and oral

pathology. He is professor emeritus of the department of periodontics at the University of Michigan School of Dentistry. He has played an active role in many professional organizations, is a former director and chairman of the board of the American Board of Periodontics and served 20 years as a dental consultant to the WHO in Geneva. He has published more than 130 articles and co-authored textbooks on periodontics and occlusion.

27. Enid A. Neidle

Dr. Neidle is a noted and foremost authority in physiology as well as an outstanding researcher in pharmacology/therapeutics, an educator, a prolific writer (over 60 publications) and a reknowned

presenter (over 100). She has held professor and head of departments at the New York University School of Dentistry, was an assistant executive director, scientific affairs (continued on page 16) for the ADA for 6½ years, and has been an outstanding spokeswoman for the profession. Dr. Neidle has held consultant positions for numerous organizations. A recipient of a large number of honors and awards, she is an honorary Fellow in the ICD, an honorary member of the ADA, and received the Colgate Palmolive/ADA Award for Outstanding Service to the Public and Profession.

28. Arthur A. Dugoni

One of America's outstanding orthodontists, he is also known for his role as an educator, writer and lecturer, and organized dentistry leader. Even while maintaining a private practice in orthodontics he became an educator. Dr. Dugoni pioneered and initiated the primary and mixed dentition orthodontic clinic at the University of the Pacific in 1963. He moved through many faculty chairs and became Dean of the School of Dentistry, UOP in 1978. Dr. Dugoni has presented more than 500 lectures, papers, and clinics and has authored over 100 published articles. As a leader he has been president of the CDA, the American Board of Orthodontics, the American Association of Dental Schools, was a member of the ADA House of Delegates, and an ADA Trustee. He has been awarded Alumnus of the Year by four universities, and has received the Hinman Medallion for Leadership, the Albert H. Ketcham Award, the Gold Medallion and Merit Award, the Chairman's Award from American Dental Trade Association, and the President's Citation from the ADA.

29. James P. Vernetti

Recognized as one of our nation's authorities in operative dentistry, Dr. Vernetti was born in Glove, AZ of immigrant parents. As a leader in his field he has served as Chief of Staff at

Coronado, CA, Hospital, has been assistant clinical professor of operative dentistry at the UCLA School of Dentistry, moved on to become associate clinical professor at the Loma Linda School of Dentistry, and finally joined the University of Texas School of Dentistry at San Antonio as full professor of operative dentistry where, in his honor, the Vernetti Award of Excellence was established. Dr. Vernetti holds membership in 16 professional international and US dental organizations, has been president of three national and two international organizations. He has been the recipient of four Fellowships, the Academy of Operative Dentistry's Award of Excellence, the Freedom Foundation Award and was cited by the Northwestern University School of Dentistry as one of the ten "Legends in Operative Dentistry." He has made clinical presentations in nine foreign countrys and many US presentations.

30. Clifford M. Sturdevant

Dr. Sturdevant has been known world-wide as a leader in dental education and as an authority on operative dentistry. Throughout his long career, he has been actively involved in numerous dental organizations, and in fact was a charter member of the Academy of Operative Dentistry. Among his most noteworthy

accomplishments was the textbook, The Art and Science of Operative Dentistry, first published in 1968. This textbook is still recognized as a leading textbook in operative dentistry. He has been an innovator in the realm of operative dentistry for years. Not only did he invent or codesign many devices such as the light body injection syringe for impression materials, "Jiffy tubes" for cement application, and various instrument and bur designs, but he also introduced numerous progressive concepts in operative dentistry that are still used today. The 1995 Academy of Operative Dentistry Award of Excellence was presented to Dr. Sturdevant.



Our Section and the Maryland Chapter cooperate in the International Student Exchange Program

Two reports by participating students enhance the value of our project

entistry in Ireland presents a dichotomy compared to the United States dentistry. The academic program is typically European, in that students enter the dental curriculum while still in college. After graduating from secondary school and taking the Leaving Certs (a screening exam for college admissions), they enter the dental program. Two years are focused on sciences and basic dentistry and the final two years are spent in the dental hospital working on patients, as well as a more in depth dental curriculum. In essence, this would be equivalent to a 2-3 year college education in the United States followed by dental school.

On the average, the graduating dentist would be approximately three years younger than a United States graduate. The classic dental courses in the basic sciences are similar. The texts are similar, equipment, and supplies are international and concepts and techniques are equivalent. This is due in fact to international exchange of professional ideas between the United States and Europe. The International College of Dentists is one of the facilitating groups in the exchange of professional ideas.

The private practice aspect both from the generalist and the specialist that I encountered in my travels is a little bit dissimilar to the United States. The pace and stress factor in Southern Ireland in the cities or the countryside is more akin to an outer suburban or small town United States practice. The stress factor and production levels, by comparison to the United States, are considerably less. Quality of care is not compromised, even though fees are lower and national health is dominant. The patient education is improving, but still would be classified somewhat below the average United States dental interest. There is still a significant percentage who opt for extractions and either removable or no replacement. However, the younger generations are certainly more aware of all health and are

asking for more comprehensive dentistry. The dentist is still a respected member of the community, but generally is titled as mister unless they achieve the Ph.D. program.

The International College of Dentists program was an opportunity for professional and collegial exchange. It was welcomed by the faculty at the school, the private practitioner, and the students at the hospital with sincere cordiality and great interest. They looked upon it as an opportunity for an exchange of ideas, techniques, and fraternization. This, from our standpoint, was a wonderful opportunity to compare and get some different professional viewpoints in different dental treatments. This certainly has enhanced and internationalized my view on (continued on page 22)

dentistry. This is a program that is of significant value to both the United States and Ireland and should be maintained for the benefit of the dental profession.

he Ireland Externship
Program between the
University College Cork
Dental School and the University
of Maryland at Baltimore Dental
School, sponsored by the International College of Dentists, is an
excellent program that has
benefited me both professionally
and personally. I was able to gain
insight into the practice of
dentistry in Ireland as well as
experience the culture of a lovely
country.

I spent the first week of my externship at the offices of dental practitioners within the city of Cork. During my day with a oral and maxillofacial surgeon, I was able to assist with several surgical procedures including the placement of osseointegrated dental implants. During the course of our day together, we were able to compare and contrast the practice of clinical oral and maxillofacial surgery as practiced in the United States and in Ireland. While there were many similarities, the most striking difference to me was in the quantity of patients seen in a typical day. While many practitioners in the United States maintain several treatment rooms and see many patients during the course of a day, I was informed that most practitioners in Ireland maintain one treatment room and see five to six patients during a typical day. After speaking with the practitioners I spent time with, I came to appreciate the fact that seeing less patients in a day lent itself to a higher quality of dentistry and less stress on the practitioner.

During the third week of my externship, I spent time at the dental school. The dental school at Cork is based at the regional hospital at Cork. In addition to the program in undergraduate dental education, the dental school has a program in dental hygiene which was founded two years ago. The practice of dental hygiene by licensed dental hygienists under the supervision of dentists is not as prevalent in Ireland as it is in the U.S. Most general practitioners in Ireland perform hygiene procedures on their patients and do not utilize licensed hygienists. By starting the hygiene school, the hope is to begin to utilize the team approach to overall patient management that is popular in the United States. The dental school also houses a state of the art Oral Health Services Research Center. It was established in 1983 for the purpose of conducting oral health science research projects. Services available include trial design, protocol writing, clearance with regulatory bodies, recruitment and screening of volunteers, stratification procedures, impartial interviewing techniques, clinical studies, validation procedures, microbiological measurements, biochemical tests, quality control, statistical analysis and report writing. The center was founded by Dr. Denis O'Mullane.

During the second week of my externship I was free to tour the country of Ireland. I spent several days on the west coast traveling from County Kerry to County Mayo, where I was able to meet up with members of my family, both from the U.S. and from Ireland. It was a wonderful experience to see how beautiful the country of Ireland is. The people who I met along the way were friendly and outgoing and went to great lengths

to ensure that I was having a pleasant stay.

My overall assessment of the externship program to Ireland is a very favorable one. While the experience will not give a student much knowledge in terms of clinical skills, the program has much to offer in terms of experiencing the profession of dentistry from a different prospective.

ith the approval of the USA Section Board of Regents of the International College of Dentists (ICD), the Baltimore College of Dental Surgery, Dental School, University of Maryland at Baltimore (BCDS) was the recipient of a grant to participate in the 1994 International College of Dentists Student Exchange Program. This grant was made available through the efforts of ICD Regent Dr. Harry W.F. Dressel, Jr., and Deputy Regent for Maryland, Dr. William R. Patteson, in cooperation with Dean Richard R. Ranney and Dr. Richard G. Shaffer, Secretary General, ICD. The Dental Schools of University College Cork (UCC) and Trinity College, University of Dublin (TCD), in Ireland agreed to join with BCDS in this exchange program with the support of Dean Louis Buckley (UCC) and Dean Diarmuid B. Shanley (TCD). The BCDS coordinators for this program were Dr. Mark L. Wagner, professor, department of pediatric dentistry, and Dr. Margaret B. Wilson, assistant dean for admissions and student affairs. In Ireland the coordinators were Dr. Robin O'Sullivan, anatomy department, UCC, and Dr. Liam Convery, head of pediatric dentistry, Dublin Dental Hospital, TCD.

The ICD grant allowed for the (continued on page 23)

funding of round trip air fare and \$150 for each of the student participants. Two students from BCDS and two Irish students (one each from UCC and TCD) were to be selected for the Exchange. As a result of an application process at each school Ms. Pamela Martin and Mr. Andrew Colgan, senior dental students, were selected to represent the Baltimore College of Dental Surgery; and Ms. Judith O'Meara (UCC) and Ms. Maura Cuffe (TCD), both final year students, were selected to represent their respective dental schools.

The first student exchange took place in mid-June when the students from Ireland arrived in Baltimore. Due to differences in the academic calendars of the dental schools, the BCDS students were scheduled for their trip in August. The duration of each visit was three-four weeks, and this allowed the students to meet each other. Local Baltimore area dentists, Dr. Sharon Welton and Dr. Mary O'Reilly, graciously provided housing for Ms. O'Meara and Ms. Cuffe. Accompanying them was Patrick Carey, another student from UCC. While he did not receive the financial support, accommodations were arranged through Dr. John Dermody, a BCDS postdoctoral endodontics student from Ireland.

All of the students were to have the opportunity to observe first hand the dental education, practice of dentistry, health care system and culture of the USA and Ireland. The Irish students attended clinics in every discipline, including the predoctoral general practice area and the advanced specialty clinics in endodontics, pediatric dentistry, periodontics, orthodontics, prosthodontics, and oral and maxillofacial surgery. They were exposed to research areas in the biological

sciences, as well as clinical research in pharmacology and oral medicine.

Dr. Patteson and Dr. Albert L. Ousborne, Jr., ICD member, coordinated visits to their offices, as well as the offices of a local endodontist and an oral maxillofacial surgeon. A highlight for the Irish students was a visit and tour of the National Institutes of Health (NIH) and the National Institute of Dental Research (NIDR). This was arranged by Drs. Anne and Brian O'Connell who are natives of Ireland and currently on staff at NIDR. Dr. Anne O'Connell is a part-time lecturer at BCDS and a former full-time member of the pediatric dentistry faculty. Judy, Maura and Pat had time for sightseeing in Washington and Annapolis, and trips to Boston and New York were also planned. At the time of this

writing, Ms. Martin and Mr. Colgan were looking forward to having comparable experiences in Ireland, having started their exchange program on July 30. In addition to their anticipated visits to Cork and Dublin, they were looking forward to having the opportunity to meet one of their faculty from home, Dr. John Bergquist, chair of pediodontics at BCDS, who is on sabbatical at TCD. Dr. Bergquist, a Fellow of the ICD, was anxiously awaiting their visit.

This exchange program is a very valuable experience, and similar programs will be planned for the future. All of the dental schools, BCDS, UCC and TCD, are most appreciative for the support of the ICD. The students will long remember their experiences and the work of the ICD in making this opportunity possible. •

Former NIDR Harald Löe recently received the Gold Medal Award for Excellence in Dental Research sponsored by the ADA and Cheseborough - Ponds, USA. James H. The Gold Medal is bestowed every three years to an individual, who through basic or clinical research, has contributed to the advancement of the profession of dentistry or to major improvements in the oral health of the public.

Harald received the award for a number of outstanding contributions, including his landmark research on the relationship of plaque to periodontal disease.

MASSACHUSETTS

M. Michael Cohen, an internationally known authority on pedodontics, dentistry for the handicapped and dental research, died in October, 1994.

He received his DMD from Tufts Dental School in 1928 and while a student was elevated to the Robert R. Andrews Society for the Promotion of Research. His academic career began as an instructor at Tufts and culminated in his being Associate Professor Emeritus of Oral Pediatrics. He was also assistant professor of pediatrics at Tufts University School of Medicine, visiting instructor at the Forsythe Dental Infirmary, associate dental surgeon at Beth Israél and staff member at the New England Medical Center Hospital.

After retirement, he became senior associate in pedodontics at

Harvard's School of Medicine Children's Hospital and lecturer in the Department of Oral Medicine and Oral Pathology at Harvards dental school. The M. Michael Cohen Endowed Teaching and Research Fund has been established in his honor at that school.

As a dedicated practitioner, teacher and researcher, he influenced thousands of colleagues and patients. As an internationally recognized stomatologist, he was awarded multiple citations of recognition and excellence.

As a prolific writer he authored over 70 scientific papers, a number of textbooks, and contributed to many journals.

Pennsylvania Team faced grisly work

Pittsburgh dental students join FBI & anthropologists in melding expertise to identify victims

The daunting task of identifying bodies in the scattered wreckage of Flight 427 brought together an unlikely team of FBI agents, dental students, dental faculty and anthropologists.

With many of the bodies burned, dismembered and scattered through the wooded Beaver County area, this diverse team worked days and weeks to put together a puzzle from which significant pieces are missing. Dental records, fingerprints and the location of each body fragment will be analyzed.

But first the crash scene has to be photographed, diagrammed, sketched and staked out so it can be reconstructed later. No detail can be overlooked, because its importance may not be recognized until later.

Two of the most critical clues the workers will be looking for are teeth and fingerprints, said medical examiner Dr. Charles Stahl of the Armed Forces Institute of Pathology in Washington, D.C.

No other structures in the body are so durable and fastidiously documented as teeth. A replaced tooth, a crown, a filling — even the particular kind of filling — can lead investigators to a positive identification.

Faculty and approximately 70 dental students of the University of Pittsburgh School of Dental Medicine, led by **Jon B. Suzuki**, dean and professor, were among those helping to identify the remains of victims of USAir Flight 427, which crashed outside of Pittsburgh on Sept. 8, 1994.

The faculty and students worked under the supervision of

the Allegheny and Beaver County coroners' offices with Chief Forensic Odontologist Dr. Michael Sobel, assisted by Dr. Elaine Berkowitz.





Arthur C. Reed, Houston, TX, is the 1994 recipient of the Southwestern Society of Orthodontists' (SWSO) highest honor, the Martin E. Dewey Memorial Award.

In 1988, the Dental School Alumni Association awarded her its distinguished alumnus award.

She is a diplomate of both the American Board of Oral and Maxillofacial Radiology and the American Board of Oral Medicine. She is past president of the American Academy of Oral and Maxillofacial Radiology, past secretary for the diagnostic systems group of the International Association for Dental

Research, past president of the International Association of Dento Maxillofacial Radiology. past chairman of the radiology section of the Association of American Dental Schools and current counselor of that section.
